The City Government of Tacloban thru the City Engineer's Office – Current Appropriation (GF) (1-07-04-010) intends to apply the sum of Six Hundred Two Thousand Nine Hundred Fifty Five Pesos & 95/100 (Php602,955.95) only being the Approved Budget for the Contract (ABC) to payment under the contract for the Proposed DILG Receiving Area, Tacloban City, and Construction of New CR and Bathroom at Women and Children's Shelter, WCS Compound, Paterno St., Tacloban City (consolidated). Bids received in excess of the ABC shall be automatically rejected at bid opening.

Mondays to Fridays.

A completed set of Bidding Documents may be purchased by interested Bidders from the address given below upon submission of a written letter of intent and/or its application for eligibility and latest Class "A" documents, addressed to the BAC Chairman, not later than March 31, 2017. Hard copy of the ITB from G-EPS, Document Request List, and Bid Notice Abstract should be attached to the letter of intent (LOI). Payment of a non-refundable fee for the bidding documents is Php1,000.00

Bids must be delivered to the address below on or before 2:00 PM April 4, 2017. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
