Hall and Evacuation Center at Brgy. 87, Manlurip, San Jose, Tacloban City**. Bids received in excess of the ABC shall be automatically rejected at bid opening.


Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from the City Government of Tacloban thru the Bids and Awards Committee (BAC) Secretariat, City Hall Bldg., Kanhuraw Hill, Tacloban City, and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 pm. Mondays to Fridays.

A completed set of Bidding Documents may be purchased by interested Bidders from the address given below upon submission of a written letter of intent and/or its application for eligibility and latest Class "A" documents, addressed to the BAC Chairman, not later than **12:00 PM of June 8, 2017**. Hard copy of the ITB from G-EPS, Document Request List, and Bid Notice Abstract should be attached to the letter of intent (LOI). Payment of a non-refundable fee for the bidding documents is **Php5,000.00**.

The City Government of Tacloban thru the BAC will hold a Pre-Bid Conference on **May 25, 2017, 2:00 PM** at the BAC Office, Livelihood Training Center, Balyuan, Tacloban City, which shall be open only to all interested parties who have purchased the Bidding Documents.
