Bid documents may be secured from the BAC Secretariat Office at the BAC Office, Balyuan Livelihood Training Center, Tacloban City upon payment of a non-refundable amount of **Php1,000.00** to the City Treasurer's Office.

Prospective bidders will be selected using Limited Source Bidding (LSB) as the mode of procurement, in accordance with the relevant provisions of Republic Act (RA) 9184 and the Government Procurement Policy Board (GPPB) Resolution No. 05 – 2011. A bidder will be determined as eligible and ineligible through the processes, qualifications and criteria described in the Bidding Documents. Post-qualification of the lowest calculated bid shall be conducted to determine the lowest calculated and responsive bid.

Prospective bidders should have experience in undertaking a similar project within the last five (5) years with an amount of at least 50% of the proposed project for bidding, and have key personnel and equipment (owned, leased or under purchase) available for the implementation of the project.

All particulars relative to eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).

The City Government of Tacloban reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
