Interested bidders may obtain further information from the City Government of Tacloban thru the Bids and Awards Committee (BAC) Secretariat, City Hall Bldg., Kanhuraw Hill, Tacloban City, and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 pm. Mondays to Fridays.

A completed set of Bidding Documents may be purchased by interested Bidders from the address given below upon submission of a written letter of intent and/or its application for eligibility and latest Class "A" documents, addressed to the BAC Chairman, not later than **12:00 PM of August 1, 2017**. Hard copy of the ITB from G-EPS, Document Request List, and Bid Notice Abstract should be attached to the letter of intent (LOI). Payment of a non-refundable fee for the bidding documents is **Php1,000.00**.


