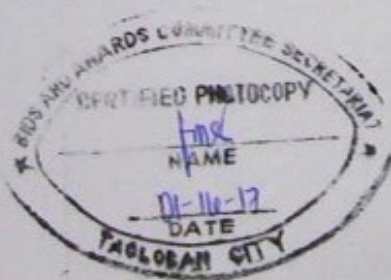
Prospective bidders may download and examine the attached Bid Documents by clicking the figure opposite the Associated Components.

Bid documents may be secured from the BAC Secretariat Office at the Executive Lounge, City Hall Bldg., Tacloban City upon payment of a non-refundable amount shown on the table above to the City Treasurer's Office.

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50 % and have key personnel and equipment (owned, leased or under purchase) available for the implementation of the project.

The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted to determine the lowest calculated and responsive bid.

All particulars relative to eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).
